# **RESOLUTION NO. 8915**

A RESOLUTION AUTHORIZING A FIVE (5%) PERCENT COST OF LIVING ADJUSTMENT FOR REGULAR EMPLOYEES OF THE CITY OF TARRANT AND TARRANT ELECTRIC AND A TWENTY (20%) PERCENT COST OF LIVING ADJUSTMENT FOR EMPLOYEES IN FIREFIGHTER and PUBLIC SAFETY POSITIONS

WHEREAS, it has been more than eighteen months since a cost-of-living adjustment for City of Tarrant employees; and,

WHEREAS, average salaries increased by 4.7% nationwide and 5.3% in Alabama for the year following the City's last COLA, and cumulative inflation has reached 11% since that wage increase; and,

WHEREAS, The City of Tarrant's pay scale is the third from the lowest when compared to the other fifteen Personnel Board municipalities on Police salaries and second from the lowest on Fire salaries., with disparities of 4-35% for entry level public safety positions; and,

WHEREAS, The City of Tarrant's employees are dedicated public servants who face the risks, dangers, and stressors that are common to their professions; and,

WHEREAS, The City of Tarrant's services rely on employee familiarity with the city and residents, which has been continuously undermined as we have a median employee tenure of only a year; and,

WHEREAS, The City of Tarrant's employees are regularly approached by other municipalities with offers for increased pay, which we are unable to match; and,

WHEREAS, The City of Tarrant requires APOST certified Police Personnel and fully certified Paramedics to fulfill basic public safety functions, but has not been able to recruit individuals who are already prepared with these types of training; and,

**WHEREAS,** The City of Tarrant has not been able to fully staff public safety positions in recent years, let alone do so within budgeted overtime allocations or with fully trained personnel; and,

WHEREAS, The City of Tarrant has experienced budget surpluses for the past two years which cover the projected cost of these raises, as reflected in "Exhibit A" at the end of this resolution.

THEREFORE, BE IT RESOLVED by the City Council of the City of Tarrant, Alabama while in regular session on Monday, June 6<sup>th</sup>, 2022, at 7:00 pm as follows:

Section 1. That all Tarrant Police Department's sworn personnel, Public Safety Dispatchers, and Corrections Officers will be moved to a Public Safety Pay Schedule, and that this new Public Safety Pay Schedule shall reflect a twenty (20%) percent Cost of Living Adjustment, effective June 7<sup>th</sup>, 2022.

Section 2. That the Tarrant Firefighter Pay Schedule shall reflect a twenty (20%) percent Cost of Living Adjustment, effective June 7<sup>th</sup>, 2022.

Section 3. That the City of Tarrant Pay Schedule for all other Regular Classified and Unclassified Employees shall reflect a five (5%) percent Cost of Living Adjustment, effective June 7<sup>th</sup>, 2022.

Section 4. That all the above expenditures, as well as any necessary or required taxes, benefits, and pension contributions, projected to total \$710,956.27 annually, shall be paid from the City of Tarrant General Fund.

Section 5. That it be recommended that the Personnel Board of Jefferson County acknowledges the City of Tarrant Resolution #8915, granting a twenty (20%) percent Cost of Living Adjustment for both the Tarrant Firefighter Pay Schedule and newly created Tarrant Public Safety Pay Schedule, and a five (5%) percent Cost of Living Adjustment, effective June 7, 2022, for the City of Tarrant Pay Schedule effective June 7, 2022. Since this request is not within twelve (12) months of an applicable election, approval of the Personnel Board of Jefferson County is not required, but copies of this resolution and the revised pay schedules shall be made available to the Board by the Appointing Authority.

# **ORDINANCE NO. 1149**

# AN ORDINANCE CONTINUING A NATURAL GAS FRANCHISE TO SPIRE ALABAMA INC.

BE IT ORDAINED by the City Council of the City of Tarrant, Alabama, in regular meeting duly assembled, a quorum being present, as follows:

Section 1. In consideration of the benefits to accrue to said City of Tarrant, Alabama (the "City") and the inhabitants thereof, Spire Alabama Inc., its successors and assigns (the "Company") is hereby given, granted and vested with the rights, authority, privileges and franchises hereinafter set forth. Nothing in this Ordinance shall be construed as granting to the Company an exclusive franchise for the purpose set forth in this Ordinance. Identical or similar franchises may be granted by the City to more than one person or entity, within all or any portion of the City. Any privileges prescribed by this Ordinance shall be subordinate to any prior lawful occupancy of the public streets, and the City Council reserves the right to reasonably designate where the Company's facilities are to be placed within the public ways.

Section 1. The Company is hereby given, granted and vested with the right, authority, easement, privilege and franchise to construct, own, maintain, operate, extend and enlarge in the City a plant or species for the manufacture, transmission, distribution and sale of gas for all purposes whatsoever in and through the City; and the consent of the City acting through the City Council, who are the proper authorities of the City is hereby given to the Company to use the streets, avenues, alleys, ways, bridges, viaduct, underpass and other public places ("Public Infrastructure") in the City for a viand all of the purposes referred to in this Ordinance. It is expressly understood that the fraschise granted herein is a privilege and not a right.

Section 3. The Company is hereby granted and vested with the right, privilege and franchise to construct, erect, lay, install, senew repair, maintain, operate, use and extend at any time of the purpose though without power for

Section 3. The Company is hereby granted and vested with the right, privilege and franchise to construct, erect, lay, install, enew repair, maintain, operate, use and extend at any time, obtaining permits only when required by City ordinance though without paying any fee therefor, its mains, conduits, appliances, meters, sensors, routers, poles, antennae, and any and all other equipment, appurtenances and fixtures as may be reasonably necessary or desirable in the operation of a natural gas distribution system (the "Company Facilities") under, along, above, and across any Public Infrastructure in the City. The City of the company of its intention to vacate the right-of-way and cooperating with the Company in reasonable attempts to obtain the necessary property rights to maintain the Company Facilities in the right-of-way.

Section 4. The said Company Facilities shall be so laid, set of constructed as not to unreasonably interfere with the proper use of the Public Infrastructure, and to that end the Company shall abide by all lawful ordinances and resolutions that have been or may be duly adopted by the governing body of the City and the Company shall, at all times using the life of the franchise, be subject to the lawful exercise of the City's police power. The City reserves the right to make reasonable rules, regulations and restrictions for the protection of buildings from fire in connection with the use of natural gas, and for the protection of persons using the directs, avenues, alley and/or other public places in the City from injury, though the City will not attenfit to ban the use of natural gas or limit a private person's right to use natural gas.

Section 5. Whenever the Company shall cause any opening or alteration to be made in any of the Public Infrastructure in the City for the purpose of laying, setting, maintaining, operating or repairing any Company Facilities, the work shall be completed within a reasonable time and the Company shall, upon the completion of such work, restore such portion of the Public Infrastructure to as good a condition as is reasonably practicable as it was before the opening or alteration was made and within a reasonable length of time thereafter. Any work completed by the Company in any Public Infrastructure shall be done in such a manner as to limited inconvenience to the inhabitants of the City.

If the grade of any Public Infrastructure traversed by any underground Company Facilities be hereafter changed by the City such that the depth of cover of the underground Company Facilities is fewer than 30 inches, and after written demand from the City, the Company will relocate at the Company's expense such underground Company Facilities within a reasonable time after such demand so that such underground Company Facilities have at least 30 inches of depth of cover. However, nothing shall limit, be construed as limiting the right, or be construed as a

waiving the right of the Company otherwise to be reimbursed by the State of Alabama, the State of Alabama Highway Department or by any other governmental agency or department other than the City for the expense of changing the grade and/or location of such mains, extensions or connections thereof.

Section 6. The Company shall defend, indemnify and hold the City, its administration, officials, and officers harmless from any and all liability or damages to persons or property to the extent resulting from an act or omission of the Company or any of its agents, servants or employees in the construction, maintenance, existence or operation of the Company Facilities within the City. The Company shall not settle any claim or suit on the City's behalf where the City admits liability without first obtaining the City's written consent. The Company shall maintain, throughout the term of the franchise, self-insurance or liability insurance (or some combination of the two) insuring the Company with regard to all damages mentioned herein caused by the Company or its agents, in the amounts of: (1) Workmen's compensation insurance as required by the laws of the State of Alabama; and (2) One Million and NO/100 Dollars (\$1,000,000.00) per occurrence for bodily injury or death to any person and Three Million and NO/100 Dollars (\$3,000,000.00) in the aggregate for bodily injury or death.

Section The Company shall have the power and authority, subject to the supervision of the Alabama Public Service Commission or other duly constituted governmental authority vested with the power now vested in the Alabama Public Service Commission to supervise and regulate public utilities in the State of Alabama, to make, adopt and enforce rates, rules and regulations for the furnishing of gas and for the reasonable operation of its plant and system and shall have the right at all reasonable hours to have access to its gas pipes and the meters of any consumer for the purpose of making repairs and other proper purposes.

Section 8. Section 9. All ordinances and parts of ordinances in conflict with this Ordinance or with any of its provisions are, to the extent of such conflict, hereby repealed. Section 10. Pursuant to Article XII, Section 228 of the Constitution of Alabama (1901), the duration of this franchise will be effective from the date this Ordinance was passed.

Section 11. As a condition to the continued existence of the franchise herein granted and as compensation or consideration for the granting thereof, the Company agrees by its acceptance hereof that it will pay to the City, in addition to all taxes now or hereafter required by law to be paid, a franchise fee of one percent (1%) of gross gas sales revenues received by the Company from the sale and delivery of gas during the preceding calendar year to customers within the corporate limits, except for gas which is sold within the corporate limits of another municipality which has granted the Company a franchise.

Section 12. This Ordinance shall be published in accordance with the applicable provisions of Section 11-45-8 of the Code of Alabama (1975). Such publication shall be done by the City

Clerk of the City and thereafter the City Clerk shall enter upon the minutes of the City, immediately after the place where this Ordinance is recorded, a certificate setting forth that such Ordinance was published in accordance with the terms hereof and the laws of the State of Alabama. The expense of such publication shall be paid by the Company.

Section 13. The Company shall, within ninety (90) days of the date of this Ordinance, file with the City Clerk of the City a written acceptance of this Ordinance and of the franchise granted hereby. Upon filing by the Company with the Clerk of the City of a written acceptance of this Ordinance and of the franchise granted hereby, this Ordinance shall constitute a contract between the City and the Company and their respective successors and assigns.

Section 14. The enactment of this franchise in the manner hereinabove provided shall have the effect of terminating any other franchise heretofore granted by the City and then held by the Company covering the distribution of gas in the City and territory contiguous thereto.




