The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday June 3, 2024, at 7:00 PM at City Hall.

Mayor Wayman A. Newton called the meeting to order at 7:00 PM following the council work session that began at 6:00PM to discuss items on the agenda and other matters.

City of Tarrant Fire Chief Patrick Bennet lead those in attendance in the invocation. City of Tarrant City Clerk Laverne Knight lead those present in the Pledge of Allegiance.

Mayor Newton asked for a roll call. The following officials were present during the roll call:

First, Barbara Jackson and Julianne Tharp provided an Environmental presentation update from the Greater Birmingham Alliance to Stop Pollution (GASP) for the City of Tarrant Mayor and Council, and all those in attendance. Ms. Jackson provided all in attendance with an update on public permits relating to pollution that recently expired. GASP will be providing talks and community sessions in mid-July 2024 for the public. Ms. Jackson and Ms. Tharpe provided verbally their phone numbers for all interested individuals.

Second, Linda and James Lowery presented concerns on the City of Tarrant Public Works Department and their recent construction of a ditch/ravine on the front edge of their yard. Mayor Newton explained the water drainage problem in the City of Tarrant and assured the Lowery's that he would personally stop by to view the recent construction.

Second, Billy Denton expressed concern over his business that was recently opened in the City of Tarrant. Though the City of Tarrant Business License was granted it was found that there was an error in zoning resulting in the cancellation of the Business License. Deputy Mayor Lisa Baker informed the Council on a clause at the bottom of all City of Tarrant Business License requiring compliance to proper zoning. The Council rejected Mr. Dentons appeal on the re-issuance of a City of Tarrant Business License.

Third, Charles Johnson expressed City of Tarrant, Jefferson County and City of Birmingham boundary concerns regarding installation of certain signs and lights. The Mayor relayed the concerns by stating he will provide Mr. Johnson with the County Commissioners contact information.

There being no further comments Mayor Newton entertained a motion to adjourn. Councilor Anderson moved to make motion to adjourn the meeting. Councilor Bryant seconded the motion. A verbal vote was conducting with all in favor. Meeting ended at 7:33 pm.

ORDINANCE NO. 1162

AN ORDINANCE ESTABLISHING AND CREATING THE CITY OF TARRANT ALABAMA POLICE DEPARTMENT.

SECTION I. TITLE

This Ordinance shall be known and cited as the "City of Tarrant Alabama Police Department Ordinance" and shall be codified as determined by the editor of the Code of Ordinances of the City of Tarrant.

SECTION 2. PURPOSE

The purpose of the City of Tarrant Alabama Police Department is to protect and to serve the residents and visitors of the City by maintaining public order, deterring crime, investigating criminal activities, and upholding neclaws and ordinances of the City, the laws and Constitution of the State of Alabama, and the laws and Constitution of the United States of America.

SECTION 3. CREATION OF THE PONCE DEPARTMENT

- A. Under the authority glar to the Council in Alabama Code § 11-43-55 (1975), the City of Tarrant Alabama Police Department is the primary law enforcement agency for the City.¹
- B. The Police Department is restorable for enforcing local, state, and federal laws within the City limits.

SECTION 4. ORGANIZATION AND STRUCTURE

- A. The Police Department shall consist of the following divisions or units, which may be modified as deemed necessary by the Chief of Police:
 - 1. Patrol Division;
 - 2. Investigations Division;
 - 3. Special Operations Division;
 - 4. Administrative Division;
 - 5. Dispatchers; and
 - 6. Corrections.

B. Under Alabama Code § § 11-43-5 and 11-43-55 (1975), the Chief of Police shall be appointed by the City of Tarrant Alabama City Council and shall be responsible for the general supervision of the City of Tarrant Alabama Police Department. Nothing in this paragraph, however, is intended to affect any rights the Mayor has under the Alabama Code or to remove any rights of the Mayor under Alabama law.

¹ Alabama Code § 11-43-55 (1975): "Except as otherwise provided in this title, the council shall have power to establish a police force and to organize the same under the general supervision of the chief of police, and to provide one or more station houses and to require all things necessary for the maintenance of an efficient police department."

SECTION 5. POWERS AND AUTHORITY

- A. Officers of the Police Department shall have the authority to enforce all applicable laws, ordinances, and regulations within the City at the direction, and under the supervision of the Chief of Police duly appointed by the Tarrant City Council in conformity with the laws of the State of Alabama and the rules and regulations of the Alabama Peace Officer Standards and Training Commission ("APOST"). Nothing in this paragraph, however, is intended to affect any rights the Mayor has under the Alabama Code or to remove any rights of the Mayor under Alabama law.
- B. The Police Department members having been certified as sworn law enforcement officers by the APOST, holding such certification and having been recommended to the City Council by the Police Chief of the City of Tarrant, shall have the power to make arrests, conduct investigations. and use reasonable force when necessary to carry out their duties, in conformity with applicable Alabama State Laws and Constitution of the State of Alabama and the Constitution of the United States.
- C. All Officers of the Police Department selected and appointed shall be from a list of eligibles provided by the Perconnel Board of Jefferson County, Alabama ("PBJC"), consistent with its rules and regulations and subject to PBJC jurisdiction.

SECTION 6. RESPONSIBILITIES AND DUTIES

- A. The Police Department shall be responsible for, at minimum, the following:
- 1. responding to emergency calls and maintaining public safety;
- 2. recording such calls and reports of public after concerns and regularly report same to the City Council on a monthly basis;
- 3. the Chief of Police shall serve as the City's custosian of all police records and any record generated by any officer or employee of the Tarrant Police Department;
- 4. investigating and preventing criminal activities;
- 5. collaborating with other law enforcement agencies;
- 6. providing community outreach and engagement programs;
- 7. maintain and operate a jail or similar such facility to house individuals ordered held by the Tarrant Municipal Court or any Court of competent jurisdiction;
- 8. register monitor and report the registration of convicted sex offender in compliance with state and federal law
- 9. acquire, assign, account for, store all equipment owned operated and used in the ferreting out of criminal violation of the City;
- 10. maintaining records and documentation in accordance with legal requirements;

- 11. the Police Chief in cooperation with the City Attorney shall promulgate rules, regulations, policies, and procedures and shall timely submit same to the Tarrant City Council for ratification and implementation of those rules, regulations, policies, and procedures;
- 12. any other activity or duty routinely handled by a police department within the state of Alabama and for which the department is authorized to handle by state and federal law; and
- 13. any other duty or requirement as may be directed by the City Council that the Police Department is lawfully permitted to take.

SECTION 7. BUDGET AND FUNDING

A. The City of Arrant Alabama City Council shall allocate necessary funds for the operation and maintenance of the Dolice Department through the annual City budget. The Chief of Police shall be responsible for creating a ordget on an annual basis and submitting same to the Mayor and the City Council for consideration.

B. The Police Department managed funding from state and federal grants, as well as other sources, to enhance its capabilities and services. All such funds shall be held by the City of Tarrant pursuant to its normal financial accounting practices.

SECTION 8. REPEALER

Any and all provisions in an existing ordinates of the City of Tarrant Code of Ordinances that conflicts with or are contrary to any term or provision in this Ordinance shall be and are hereby repealed. Specifically, but not limited to, any provision in section 2-1 of the City of Tarrant Code of Ordinances that is contrary to or in conflict with this Ordinance is hereby repealed.

SECTION 9. SAVINGS CLAUSE

Any part, section, paragraph, sentence, clause, or word which may be declared unconstitutional or invalid by a court of competent jurisdiction shall not affect or otherwise alter the remainder of the Ordinance which shall remain in full force and effect.

SECTION 10. EFFECTIVE DATE

This ordinance shall take effect upon its adoption, approval, and publication or otherwise provided for by law.

RESOLUTION NO. 9168

A RESOLUTION AUTHORIZING AND APPROVING THE CITY OF TARRANT TO PROVIDE A PORTION OF THE INCREASED COSTS TO THE JEFFERSON COUNTY COMMISSION IN AID OF THE MAYOR LOXCIL TUCK STORM SHELTER.

WHEREAS, the City of Tarrant, Alabama ("the Community") has reached an agreement with Jefferson County, Alabama ("the County") to establish a storm shelter; and,

WHEREAS, tornadoes have caused significant danger and destruction in our neighboring communities, and created deep concerns over the lack of existing storm shelters within the community; and,

WHEREAS, there has been an ongoing call from residents for a storm shelter within the City limits; and,

WHEREAS, there has been an unforeseen increased of costs in funding indicated by the Jefferson County Commission; and,

WHEREAS, the Jefferson County Commission requests the City of Tarrant provide approximately \$25,000.00 to supplement the unforeseen increased costs for the building of the officially named Mayor Loxcil Tuck Storm Shelter.

THEREFORE, BE IT RESOLVED by the City Council of the City of Tarrant, Alabama, while in regular session on Monday, June 17, 2024, at 7:00 pm as follows:

WHEREAS, GameDay Athletic Surfaces ("GameDay") is a known company providing these natural ture and athletic complex construction, renovation, and maintenance for a host of multicular athletic complexes and school systems in and throughout this area and the state; and

WHEREAS, GameDay has provided a Juote for the required services in order to make the playing field ready for play of the City's youth recreational league upcoming season (a copy of the quote is attached as Exhibit "A"); and

WHEREAS, because the quote and projected work in Low the \$100,000.00 threshold for a public work that would require the issuance of a public bid pursuant to Act 2023-497, the City Council may approve the expenditure of the funds pursuant to the attached quote; and

WHEREAS, having considered the foregoing, the City Council of the City of Tarrant, Alabama, ("City Council") finds it in the best interest of the health, safety, and welfare of its citizens to approve the scope of work contained in the attached exhibit and authorize the expenditure of the funds for the work to be performed to GameDay.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Tarrant, Alabama, while in regular session a quorum duly assembled on Monday, June 17, 2024, at 7:00 p.m. as follows:

Section 1. The above-stated preamble is hereby adopted and incorporated as if fully set out herein.




