ORDINANCE NO. 1162

AN ORDINANCE ESTABLISHING AND CREATING THE CITY OF TARRANT ALABAMA POLICE DEPARTMENT.

SECTION 1. TITLE

This Ordinance shall be known and cited as the "City of Tarrant Alabama Police Department Ordinance" and shall be codified as determined by the editor of the Code of Ordinances of the City of Tarrant.

SECTION 2. PURPOSE

The purpose of the City of Tarrant Alabama Police Department is to protect and to serve the residents and visitors of the City by maintaining public order, deterring crime, investigating criminal activities, and upholding the laws and ordinances of the City, the laws and Constitution of the State of Alabama, and the laws and Constitution of the United States of America.

SECTION 3. CREATION OF THE POLICE DEPARTMENT

- A. Under the authority granted to the Council in Alabama Code § 11-43-55 (1975), the City of Tarrant Alabama Police Department is the primary law enforcement agency for the City.¹
- B. The Police Department is responsible for enforcing local, state, and federal laws within the City limits.

SECTION 4. ORGANIZATION AND STRUCTURE

- A. The Police Department shall consist of the following divisions or units, which may be modified as deemed necessary by the Chief of Police:
 - 1. Patrol Division;
 - 2. Investigations Division;
 - 3. Special Operations Division;
 - 4. Administrative Division;
 - 5. Dispatchers; and
 - 6. Corrections.

B. Under Alabama Code § § 11-43-5 and 11-43-55 (1975), the Chief of Police shall be appointed by the City of Tarrant Alabama City Council and shall be responsible for the general supervision of the City of Tarrant Alabama Police Department. Nothing in this paragraph, however, is intended to affect any rights the Mayor has under the Alabama Code or to remove any rights of the Mayor under Alabama law.

¹ Alabama Code § 11-43-55 (1975): "Except as otherwise provided in this title, the council shall have power to establish a police force and to organize the same under the general supervision of the chief of police, and to provide one or more station houses and to require all things necessary for the maintenance of an efficient police department."

SECTION 5. POWERS AND AUTHORITY

- A. A. The City of Tarrant Alabama City Council shall allocate necessary funds for the operation and maintenance of the Police Department through the annual City budget. The Chief of Police shall be responsible for creating a budget on an annual basis and submitting same to the Mayor and the City Council for consideration.

B. The Police Department may receive funding from state and federal grants, as well as other sources, to enhance its capabilities and services. All such funds shall be held by the City of Tarrant pursuant to its normal financial accounting practices.

SECTION 8. REPEALER

Any and all provisions in an existing ordinance of the City of Tarrant Code of Ordinances that conflicts with or are contrary to any term or provision in this Ordinance shall be and are hereby repealed. Specifically, but not limited to, any provision in section 2-1 of the City of Tarrant Code of Ordinances that is contrary to or in conflict with this Ordinance is hereby repealed.



ORDINANCE NO. 1162

AN ORDINANCE ESTABLISHING AND CREATING THE CITY OF TARRANT ALABAMA POLICE DEPARTMENT.

SECTION 1. TITLE

This Ordinance shall be known and cited as the "City of Tarrant Alabama Police Department Ordinance" and shall be codified as determined by the editor of the Code of Ordinances of the City of Tarrant.

SECTION 2. PURPOSE

The purpose of the City of Tarrant Alabama Police Department is to protect and to serve the residents and visitors of the City by maintaining public order, deterring crime, investigating criminal activities, and upholding the laws and ordinances of the City, the laws and Constitution of the State of Alabama, and the laws and Constitution of the United States of America.

SECTION 3. CREATION OF THE POLICE DEPARTMENT

- A. Under the authority granted to the Council in Alabama Code § 11-43-55 (1975), the City of Tarrant Alabama Police Department is the primary law enforcement agency for the City.¹
- B. The Police Department is responsible for enforcing local, state, and federal laws within the City limits.

SECTION 4. ORGANIZATION AND STRUCTURE

- A. The Police Department shall consist of the following divisions or units, which may be modified as deemed necessary by the Chief of Police:
 - 1. Patrol Division;
 - 2. Investigations Division;
 - 3. Special Operations Division:
 - 4. Administrative Division:
 - 5. Dispatchers; and
 - 6. Corrections.
- B. Under Alabama Code § \$ 11-43-5 and 11-43-55 (1975), the Chief of Police shall be appointed by the City of Tarrant Alabama City Council and shall be responsible for the general supervision of the City of Tarrant Alabama Police Department. Nothing in this paragraph, however, is intended to affect any rights the Mayor has under the Alabama Code or to remove any rights of the Mayor under Alabama law.

Alabama Code § 11-43-55 (1975): "Except as otherwise provided in this title, the council shall have power to establish a police force and to organize the same under the general supervision of the chief of police, and to provide one or more station houses and to require all things necessary for the maintenance of an efficient police department."

SECTION 5. POWERS AND AUTHORITY

- A. Officers of the Police Department shall have the authority to enforce all applicable laws, ordinances, and regulations within the City at the direction, and under the supervision of the Chief of Police duly appointed by the Tarrant City Council in conformity with the laws of the State of Alabama and the rules and regulations of the Alabama Peace Officer Standards and Training Commission ("APOST"). Nothing in this paragraph, however, is intended to affect any rights the Mayor has under the Alabama Code or to remove any rights of the Mayor under Alabama law.
- B. The Police Department members having been certified as sworn law enforcement officers by the APOST, holding such certification and having been recommended to the City Council by the Police Chief of the City of Tarrant, shall have the power to make arrests, conduct investigations, and use reasonable force when necessary to carry out their duties, in conformity with applicable Alabama State Laws and Constitution of the State of Alabama and the Constitution of the United States.

Any part, section, paragraph, sentence, clause, or word which may be declared unconstitutional or invalid by a court of competent jurisdiction shall not affect or otherwise alter the remainder of the Ordinance which shall remain in full force and effect.

SECTION 10. EFFECTIVE DATE

This ordinance shall take effect upon its adoption, approval, and publication or otherwise provided for by law.



The Board is in favor of such request. Accordingly, please be advised that the Board does hereby grant to the City a license to use the Property on the following terms and conditions:

- 1. Subject to the provisions of Paragraph 6 below, the term of the license granted herein shall commence on the date hereof and continue until June 30, 2025 (the "Term") with the option for the Board to extend the resolution in five-year increments.
- 2. The City acknowledges and agrees that the Board has not made and does not make any representations or warranties concerning the physical condition of the Property or as to any other matters and the City agrees that its use of the Property shall be on an "AS IS", "WHERE IS", "WITH ALL FAULTS" basis.
 - 3. Throughout the Term, the Property shall be used only for the Intended Use.
- 4. Throughout the Term, the City shall, at its sole cost and expense, be responsible for the maintenance, upkeep, repair and replacement of the Property including, without limitation, undertaking, at the sole cost and expense of the City, the improvements to the Property as set forth in the proposal made to the City by Game Day Athletic Surfaces attached hereto as **Exhibit B** and incorporated herein by reference, which improvements are hereby authorized by the Board.
- 5. Throughout the Term, the City shall, at its sole cost and expense, obtain and maintain commercial general liability insurance insuring the City, the Board and any other persons

designated by the Board against any and all liability for injury to or death of a person or persons and for damage to property occasioned by or resulting from or out of the use of the Property or in any way occasioned by or arising out of any activities conducted by the City or any of its agents or employees in or upon the Property, the limits of which to be in a combined single limit for both damage to property and personal injury and in amounts not less than \$2,000,000 for each occurrence with an annual aggregate limit of not less than \$5,000,000. The City agrees to provide to the Board a certificate of insurance for the foregoing required insurance, which certificate shall name the Board as an additional insured. The City further agrees to provide to the Board replacement certificates at least 30 days prior to the expiration of such policy.

- 6. To the greatest extent allowed by law, the City does hereby indemnify, agree to defend and hold the Board, its agents and employees (each an "Indemnified Party") harmless from and against any and all claims, actions, losses, damages, liabilities, fines, verdicts, judgments, costs and expenses of any nature whatsoever, including attorneys' fees and defense, investigation, discovery, court and other costs, suffered, paid or incurred by any Indemnified Party (each, a "Loss"), including those resulting from any claims, demands, actions, causes of action or other legal or administrative proceedings at law or in equity against any Indemnified Party (each, a "Claim"), arising from or relating to any of the following: (a) personal injury (including death), property damage, loss of use or profits arising from or relating to the use of the Property by the City or any person or entity the City brings, allows or permits to enter upon the Property (each a "City Party"), including any Claim by a City Party, in all cases irrespective of whether any Loss or Claim is caused or alleged to be caused by the sole, contributory or concurrent passive negligence of any Indemnified Party; (b) the City's breach of any representation, warranty, covenant or agreement contained herein; and (c) violation by the City or any City Party of any applicable law, rule, regulation, ordinance or permit relating to the Property or any activities thereon.

Map Depicting Property


