CITY OF TARRANT COUNCIL MEETING MINUTES OCTOBER 7, 2024 TARRANT CITY HALL

The City Council of the City of Tarrant, Alabama, met in a regularly scheduled meeting on Monday October 7, 2024, at 7:00 PM at City Hall.

Mayor Pro Tem Tracie Threadford called the meeting to order at 7:00 PM immediately following the council work session that began at 6:00 PM to discuss items on the agenda and other matters.

City of Tarrant Fire Chief, Patrick Bennet, lead those in attendance in the invocation. City Clerk Laverne Knight lead those present in the Pledge of Allegiance.

Mayor Pro Tem Threadford asked for a roll call. The following officials were present during the roll call:

Mayor Wayman A. Newton entered the council meeting chambers at approximately 7:02 pm.

The minutes from the September 16, 2024 regularly scheduled council meeting were presented for review and approval. Councilor Threadford moved to approve the minutes of the September 16, 2024 meeting. Councilor Bryant seconded the motion. Mayor Newton called for a vote.

The yeas being five (5) and the nays being zero (0), with one (1) member not voting, the motion to approve the minutes were adopted, and the minutes for September 16, 2024 council meeting were approved.

The Mayor apologized for the 'Helping Hands Giveaway' cancellation on Saturday, September 28, 2024 from 11am to 2pm at Ford Avenue. The event is rescheduled for October 19, 2024 from 3pm to 6pm at Ford Ave., and it will be in conjunction with another organization of recognition of Hispanic Heritage Month. The Mayor invited the community to attend the public event. The Mayor also reminded all those in attendance of the annual 'Trunk or Treat.' The 2024 'Trunk or Treat' will be scheduled for Thursday October 31st from 6:00 pm to 8:00* pm, asterisk referring to pending on the availability of candy. In addition, the Mayor invited all businesses entities,

individuals and asked for volunteers to participate by providing candy from their open trunks at the City of Tarrant Ford Avenue. The City Hall phone number 205 849 2800 was provided as a means of contact for the business entities, individuals and volunteers. Volunteers to be present at 5:30 to help set up. The Mayor introduced Sheriff Pettway and publicly provided him with a proclamation from the City of Tarrant Mayors Office in recognition of his support for the City of Tarrant in aiding with recent criminal cases.

Councilor Threadford informed all those in attendance that she will be hosting a job fair at the Tarrant Recreation Center on 1232 Faye Drive on Friday, October 11, 2024 from 9:00 am to 2:00 pm. Recruiters will be present with possible on the spot hiring. Companies in attendance will include Walden Security, Kemper Insurance Life Changing Kids, Tarrant Board of Education, Drummond Company, Staff Zone and many more. Councilor Threadford called Chief Major forward to the podium. Councilor Threadford thanked Chief Major and all the Tarrant Police force including Officer George for their work as Tarrant Police officers in response to keeping everyone safe and their professionalism in attendance at various City of Tarrant events from alumni gatherings to sports games. Councilor Threadford also thanked and congratulated Councilor Freeman for coordinating the installation of the recent traffic light that's been in need for the past 50 years.

Councilor Veronica Bandy Freeman announced that there is a domestic violence training at 309 23rd St North in Birmingham this Thursday October 10, 2024 from 9am to 11am. Phone number of 205 322 9922 extension 328 for interested individuals was provided.

Councilor Threadford acknowledged breast cancer awareness by attending the Destined for Greatness Ministry conference and congratulated its First Lady Tracy Wright. Councilor Threadford also confirmed her attendance of Pastor Everson of New Faith Ministries for their dedication service in the City of Tarrant. Councilor Threadford extended a welcome to the New Faith Ministries.

Councilor Veronica Banday Freeman also announced that she has been entered into the final list on the National League of Cities Board of Directors for the United States of America. The results will be confirmed in November 2024, and that membership will highlight the City of Tarrant.

Councilor Matthews acknowledged the Tarrant Fire Department and thanked in attendance Chief Bennett on behalf of a citizen who was deeply appreciative of a particular fire fighter in Tarrant who went above and beyond in ensuring her husband was treated properly the day before. The anonymous Tarrant citizen also affirmed that other Fire Departments in other States do not extend their services as much as the City of Tarrant Fire Department had performed. The respect and the kindness that the Tarrant fire fighter also upheld was also acknowledged by the anonymous Tarrant citizen, and she recommended the fire fighter who serviced her husband have a positive evaluation inserted in his personnel file. Councilor Matthews also thanked and acknowledged the Tarrant Police Department and referred to them as 'go getters.'

Councilor Veronica Freeman affirmed that the Human Society phone number is on Facebook and tried to put on Tarrant page but was unsuccessful. If anyone sees stray dogs please call the number and provide the location.

There were no committee reports.

Councilor Anderson confirmed a Public Works meeting. Discussed at the meeting were Public Works employees and estimates. Councilor Threadford asked for the outcome in regards to the Recreation Department public works employee request. Parks and Recreation request was not discussed at the committee meeting. There was discussion on public works equipment. The Recreation Department Head will provide estimates for lawn mowers.

The Mayor and Council moved on to Old Business.

Mayor Newton introduced and read Resolution No. 9191. A Resolution Removing Chief Wendell Major from the Office of Chief of Police for the City of Tarrant. Mayor Newton did not move to approve the Resolution No. 9191, and did not request a seconder due to interest of time. Mayor Newton asked the City Clerk to add Resolution No. 9191 to next regular Councilor meeting and

affirmed the Resolution will not get a second. The City Clerk affirmed it will be added to the next meeting.

Councilor Bryant introduced and read Resolution No. 9192, A Resolution Authorizing and Approving the City of Tarrant to Enter into a Purchase Agreement with Axon Enterprises, Inc. Councilor Bryant moved to approve Resolution No. 9192. Councilor Anderson seconded the motion. Mayor Newton expressed unreadiness. There was discussion on the company and its reputation as a high end merchandise vendor in relation to the City of Tarrants affordability. Budget and audit discussions led to the question on the City of Tarrants affordability. Salaries and number of employees were brainstormed for reduction costs for the City of TarrantCouncilor Threadford asked the Chief of Police if other estimates can be retrieved. The Chief of Police affirmed that Axon Enterprises, Inc. are the industry standard operated company Nationwide for law enforcement. Chief Major continued by stating that Tazers cannot be bought elsewhere due to law enforcement standardization, but body cameras can be bought from other countries. City of Tarrant citizen Tamura Mclellan intervened and publicly asked if grants could be resorted. Councilor Threadford stated that there is currently a \$150k grant that is in default that is affecting future grant applications. Mayor Newton responded by stating the \$150k is in default due to the Police Chiefs unaccountability in forwarding necessary documents to the Deputy Mayor, Lisa Baker. Councilor Threadford disagreed the Chief of Police had no part in the default grant by referencing an email by the Department of Justice and that the default outcome have an effect on City of Tarrant future grants. Councilor Freeman reminded all in attendance as to why all Department Heads need to be in attendance so that questions in comparison to current issues can be answered by the Heads who are specialized in the said areas. After discussion, Councilor Anderson moved to approve Resolution No. 9192 to the next meeting. Councilor Threadford seconded the motion. Mayor Newton called for a vote.

WHEREAS, based on the findings of misconduct from the April, 2024 independent investigation and the current, ongoing misconduct and exposure to harm to law enforcement officers, citizens and the City of Tarrant, Chief Wendell Major is due to be removed from the Office of the Chief of Police of the City of Tarrant for cause.



Audit Scope and Objectives

We will audit the financial statements of the governmental activities, the business-type activities, the aggregate discretely presented component units, each major fund, and the aggregate remaining fund information, and the disclosures, which collectively comprise the basic financial statements of City of Tarrant Electric Department as of and for the year ended June 30, 2024. Accounting standards generally accepted in the United States of America (GAAP) provide for certain required supplementary information (RSI), such as management's discussion and analysis (MD&A), to supplement City of Tarrant Electric Department's basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. As part of our engagement, we will apply certain limited procedures to City of Tarrant Electric Department's RSI in accordance with auditing standards generally accepted in the United States of America (GAAS). These limited procedures will consist of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We will not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient appropriate evidence to express an opinion or provide any assurance. The following RSI is required by GAAP and will be subjected to certain limited procedures, but will not be audited:

- 1) Management's Discussion and Analysis
- 2) Schedule of Changes in Net Pension Liability
- 3) Schedule of Employer Contributions
- 4) Notes to Required Supplementary Information

We have also been engaged to report on supplementary information other than RSI that accompanies City of Tarrant Electric Department's financial statements. We will subject the following supplementary information to the auditing procedures applied in our audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS, and we will provide an opinion on it in relation to the financial statements as a whole:

- 1) Schedule of Operating Revenues
- 2) Schedule of Operating and Maintenance Expenses
- 3) Organization Data

The objectives of our audit are to obtain reasonable assurance as to whether the financial statements as a whole are free from material misstatement, whether due to fraud or error; issue an auditor's report that includes our opinion about whether your financial statements are fairly presented, in all material respects, in conformity with GAAP; and report on the fairness of the supplementary information referred to in the second paragraph when considered in relation to the financial statements as a whole.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Misstatements, including omissions, can arise from fraud or error and are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment of a reasonable user made based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements

We will conduct our audit in accordance with GAAS and will include tests of your accounting records and other procedures we consider necessary to enable us to express such opinions. As part of an audit in accordance with GAAS, we exercise professional judgment and maintain professional skepticism throughout the audit.

We will evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management. We will also request written representations from your attorneys as part of the engagement.

We may share confidential information about you with these service providers but remain committed to maintaining the confidentiality and security of your information. Accordingly, we maintain internal policies, procedures, and safeguards to protect the confidentiality of your personal information. In addition, we will secure confidentiality agreements with all service providers to maintain the confidentiality of your information and we will take reasonable precautions to determine that they have appropriate procedures in place to prevent the unauthorized release of your confidential information to others. In the event that we are unable to secure an appropriate confidentiality agreement, you will be asked to provide your consent prior to the sharing of your confidential information with the third-party service provider. Furthermore, we will remain responsible for the work provided by any such third-party service providers.

Our audit of the financial statements does not relieve you of your responsibilities.

Audit Procedures-Internal Control

We will obtain an understanding of the government and its environment, including the system of internal control, sufficient to identify and assess the risks of material misstatement of the financial statements, whether due to error or fraud, and to design and perform audit procedures responsive to those risks and obtain evidence that is sufficient and appropriate to provide a basis for our opinions. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentation, or the override of internal control. An audit is not designed to provide assurance on internal control or to identify deficiencies in internal control. Accordingly, we will express no such opinion.

However, during the audit, we will communicate to management and those charged with governance internal control related matters that are required to be communicated under AICPA professional standards.

We have identified the following significant risks of material misstatement as part of our audit planning:

According to GAAS, significant risks include management override of controls, and GAAS presumes that revenue recognition is a significant risk. Accordingly, we have considered these as significant risks. Additionally, improper recognition and expenditure of funds are considered significant risks.

Audit Procedures—Compliance

As part of obtaining reasonable assurance about whether the financial statements are free of material misstatement, we will perform tests of City of Tarrant Electric Department's compliance with the provisions of applicable laws, regulations, contracts, and agreements. However, the objective of our audit will not be to provide an opinion on overall compliance and we will not express such an opinion.
